The project contemplates acquiring the existing cortijo and developing it into a 44-room luxury hotel, with the possibility to expand up to approximately 60 rooms through three new, modern buildings integrated into the landscape. The concept blends whitewashed Andalusian architecture, patios and courtyards with contemporary rooms, spa, pool and a gourmet restaurant, designed to appeal to high-end leisure guests, wellness travellers and exclusive events.

Costa del Sol is one of Spain's most in-demand destinations, with year-round tourism, strong luxury and golf segments and a growing market for eco-tourism and retreats. The location of Cortijo Vizcaronda positions it to capture this consistent demand, leveraging proximity to Sotogrande, Marbella and Gibraltar, as well as Puerto de la Duquesa, while offering an intimate countryside setting that stands out from standard coastal hotels.

From an investment perspective, the project combines a competitive purchase price of approximately €3,800,000, to create a fully repositioned asset in a market where premium room rates and high occupancy levels support attractive returns. The existing cortijo structure, authentic charm and established access dramatically shorten time-to-market compared with greenfield developments, while the flexibility of 44–60 keys allows tailoring the final concept to the operator's brand and strategy.

Cortijo Vizcaronda can operate as a boutique hotel with spa and fine dining restaurant, complemented by weddings, corporate retreats and private events, or be positioned as a wellness, yoga and eco-retreat taking full advantage of the natural surroundings. Thanks to its layout, the property can also be configured for partial buy-outs, making it particularly appealing for high-spending groups seeking exclusivity.
